- a) **Marijuana Cultivation Permits:** This discussion will follow up on a letter to the County Agricultural Commissioner and Planning Department asking for: 1) referrals for marijuana grow permits; and 2) specific information about a pending grow permit on Dehaven Creek Road. - b) **Camping Issue:** A complaint will be discussed about illegal camping resulting in environmental health and related concerns at two locations along Highway 1. Possible action includes contacts with responsible County and State agencies.
